

Fund Pricing Error

There were pricing errors that occurred on Thursday, May 6, 2010, in a number of Russell funds, and corrections will begin on Monday, May 10, 2010.

The Russell Investment Company (RIC) funds impacted include:

- Russell International Developed Markets Fund
- Russell Emerging Markets Fund
- Russell Global Equity Fund
- RIC Equity Growth Strategy Fund

The RIF funds impacted include:

- Non-US Fund

These errors overstated these Funds' reported net asset values for May 6, 2010. Today, May 10, 2010, Russell will begin the process of correcting trades for Fund Shareholders who purchased, exchanged or redeemed these Funds on May 6. The correction process will happen as follows:

- Today, May 10, 2010, we will begin correcting the May 6th transactions.
- Specifics of corrections will be determined based on analysis with the goal of minimizing impact to distribution partners.
- We will work with firms' back offices or platform providers to complete the details of the correction process.
