The managers in this fund are selected based on both the tax sensitivity of their investment approach and their stock selection abilities. Russell chooses managers that use many different investment styles, from ones that look for companies they believe have rapidly growing earnings to those that look for companies that are undervalued. Managers in this fund typically hold stocks over a longer investment horizon than in an average large-cap fund that is not tax managed, as long as a stock's fundamentals remain strong. As a result of this longer-term investment horizon, this approach typically avoids short-term capital gains, which should produce a more tax-efficient portfolio over time.

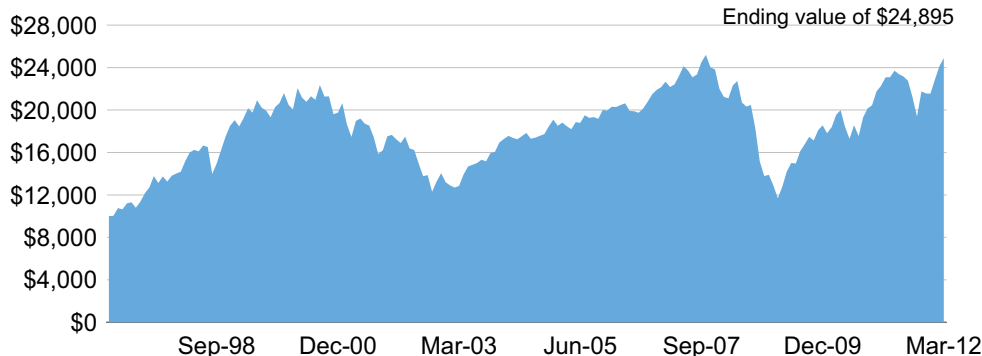
